Tenerezze Purificanti per il viso - Scrub Oil

Ingredients

Helianthus annuus seed oil*, Olea europaea virgin oil*, Calendula officinalis extract*, Prunus armenaica seed powder*, Hypericum perforatum extract*, Chamomila recutita extract*, Lavandula officinalis extract* , Citrus aurantium dulcis oil.

* Ingredients from Organic Agriculture 99,8% of the total.

Active ingredients

Helianthus annuus seed oil*, Olea europaea virgin oil*, Calendula officinalis extract*, Prunus armenaica seed powder*, Hypericum perforatum extract*, Chamomila recutita extract*, Lavandula officinalis extract* , Citrus aurantium dulcis oil.

Indications

The Sunflower Seed Oil rich in antioxidants, such as vitamin E offers protection and prevention of aging to skin cells.

The Virgin olive oil, thanks to its lipid composition similar, helps the sebum to restore the balance: it is therefore ideal for oily skin and for those dry. For his valuable components protects and nourishes the skin.

The microgranules Apricot kernel in virgin olive oil swell and allow gentle exfoliation of the skin of the face, thus stimulating the production of natural hyaluronic acid and then collagen.

Extracts of Chamomile and Calendula are softening, moisturizing and decongesting and in particular the Calendula is excellent as an adjuvant in the treatment of acne and black points.

Disinfectant Extract Lavender soothes and refreshes the skin.

Extract of Hypericum makes it more toned and elastic, in synergy with the essential oil of orange which exerts a stimulating effect, stimulates peripheral blood circulation, and also leaves a delicate fragrance.

How to use

Removing impurities and dead cells which suffocate the skin, the Scrub Oil makes your skin bright and clean, ready to be fed more in depth.

It is recommended for use once a week ; for skin over 40 little tonic we suggest a daily use.

Shake WELL before use: put a small amount on your hands and rub quickly the face, avoiding the eye area, then rinse. If you let the oil reabsorb well, sweep away the granules without rinsing.
